

Warranty Epic E-600

Epic Epic E-600 Moisture Protection and Adhesive Limited Warranty

Epic Flooring Adhesives Inc. (Epic) is pleased to warrant EPIC E-600 as an installation adhesive and moisture vapor retarder for use with wood flooring products over concrete substrates. The vapor retarder warranty applies to:

- Applications where concrete substrates have an moisture vapor emission rate (MVER) of up to 20lbs /1000ft²/ 24hr using the calcium chloride test (ASTM 1869) or a relative humidity of up to 90% using in-situ probes (ASTM F2170)
- Flooring must be installed according to Epic's most recently published literature and label instructions and applicable NWFAs guidelines.

This warranty covers adhesive defects that result in adhesive failure or damages to wood flooring caused by subfloor moisture vapor emission from concrete. This warranty applies for 10 years from the date of completion of installation of the floor.

Failures relating to the following circumstances are not covered by this warranty:

- Damages related to hydrostatic pressure
- Use of these products to install flooring that is not recommended for glue down installation by the manufacturer
- Damages where the moisture content in concrete substrate exceeds RH 90% using in the in-situ probe method (ASTM F2170) and/or 20lbs per 1000 ft² using the calcium chloride test (ASTM 1869)
- Inadequate surface preparation as instructed by the Epic Technical Data Sheet and NWFAs guidelines
- Inadequate adhesive coverage and transfer as instructed by the Epic Technical Data Sheet and label instructions
- Installation methods that do not comply NWFAs Guidelines and/or Epic's published instructions
- Damages related to improper housekeeping, floods and exposure to conditions outside of those recommended by the flooring manufacturer

Any claim pursuant to this limited warranty shall be in writing and shall spell out with specificity the circumstances of the claim.

In the event of a valid claim under this warranty as agreed to by Epic after investigation, Epic will pay to repair or replace, on a square foot basis, the portion(s) of the installation that is proven to be defective. Epic must have an opportunity to evaluate the claim-site in advance of any replacement work in order for Epic to be liable under this limited warranty.

Epic's liability hereunder is limited to the reasonable cost of materials and labor only.

EPIC DISCLAIMS ALL OTHER WARRANTIES EXPRESS OR IMPLIED, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE BUYER'S SOLE REMEDY FOR NONCOMPLIANCE WITH THIS LIMITED WARRANTY SHALL BE FOR THE REASONABLE COST OF MATERIALS AND LABOR TO CORRECT THE PROBLEM. IN NO CASE WILL EPIC BE LIABLE FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL ECONOMIC OR ANY OTHER DAMAGES OF ANY TYPE.
